
Changes to the constitution of NZ Macadamia Society Inc. 875370

- 2.0 The Registered Office shall be situated at the current Secretary's address.
- 3.3 Remove the word newsletters.
- 3.10 Remove entire clause
- 5.0 Membership. There shall be only one class of Full Membership
- 5.1 Full Members are any person(s) or Body Corporate(s) who subscribe to the objects of the Society, are approved for membership by the Executive and have paid their annual subscription.
- 5.2 Remove entire clause
- 5.3 Remove entire clause
- 5.5 A Register of Members shall be kept by the Treasurer and communicated to the Secretary and President
- 7.2 Remove entire clause
- 7.4 The subscription payable by each member shall become due and payable for each financial year on the first day of April.
- 9.2 The Council shall consist of the five executive officers and a representative from each region.

9.3 Area Representatives may be appointed from each region at the ASSISTANT REGISTRAR OF AGM.
